MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is made and entered into at Mumbai, on 30th October 2023.

BY AND BETWEEN

Annasaheb Patil Arthik Magas Vikas Mahamandal Limited (Government of Maharashtra undertaking), a company incorporated under Companies Act, 1956, having their its office at G.T. Hospital Compound, Badruddin Tayabji Marg, Near CSMT Station, Dhobi Talao, Chhatrapati Shivaji Terminus Area, Fort, Mumbai, Maharashtra 400001, (hereinafter referred to as "APAM" which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns)

Escorts Kubota Limited, a company existing under the provisions of the Companies Act 2013, having its registered office at 15/5, Mathura Road, Faridabad, Haryana, (hereinafter referred to as "EKL") which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns;

(APAM and EKL shall hereinafter be collectively referred to as "Parties" and individually as the "Party", as the case may be)

NOW, THEREFORE THE PARTIES MUTUALLY AGREE TO THE FOLLOWING TERMS & CONDITIONS:-

1. APAM's provides self-employment opportunities and works towards the upliftment of unemployed youth from economically backward section of the society. As per GR No. APAM/2017/PRA KRA 189/ROSWRO-1, dated 21.11.2017, new schemes were sanctioned and commissioned through their online web portal from dated 02.2.2018.
2. EKL is inter alia engaged in the business of manufacturing and sale of agricultural tractors, construction equipment, railway products and related spare parts thereof.
3. APAM and EKL are entering into this MOU for the sole benefit of the Economically Backward Class ("EBC") youth candidates who are potential beneficiaries of the scheme rolled out by APAM. Such beneficiary candidates ("Beneficiary") can visit and seek benefit from the Maharashtra dealer network of EKL wherein they will assist in providing free agriculture related training /information along with the products they purchase from EKL dealers. EKL dealers shall also assist Beneficiary making a conscious and informed choice on the latest developments in the field of agriculture related products.
4. Every Beneficiary registered under the scheme rolled by APAM, upon submission of basic details like proof of residence, AADHAR card copy and family income proofs receives a "Letter of Intent" from APAM, confirming the eligibility to get full reimbursement of interest on loan taken from any CIBIL compliant Bank / NBFC in the State of Maharashtra.
5. The parties mutually agree to follow the below-mentioned process:
 - a. APAM would identify EBC candidates/ Beneficiary (whose family income being less or up to a total of INR 8 lakhs per financial year) needing financial help for starting new enterprises or expanding existing ventures (As per Government norms).
 - b. APAM after conducting basic due diligence and compliances required under the

- c. When a Beneficiary approaches EKL authorized dealer with LOI and related documents thereto, EKL dealer may assist to connect the beneficiary to approved Banks for providing financing support to such Beneficiary.
- d. As and when the Beneficiary pays loan instalments and interest on loan amount/term loan working capital, Bank would provide statement of account as proof of payment.
- e. Upon receipt of these proofs, as per guideline, APAM would transfer the interest amount reimbursement to the designated account of the beneficiary if the installment / interest is seen to be paid in time as per expected under loan conditions. The loan repayment frequency can be monthly / quarterly and half yearly at the discretion of Bank which agrees to provide finance support to the Beneficiary. As per government guidelines, only interest component would be reimbursed directly by APAM to beneficiary as a relief under the said scheme rolled by APAM.
- f. It is understood that the LOI is neither a recommendation nor a mandate of any nature but a statement of eligibility under the scheme, hence EKL dealers will provides training / information and special rates of product to Beneficiaries.
- g. It is agreed and understood between the parties, that this MOU is primarily entered for promotion of Economically backward section of society. In the interest of Beneficiary belonging to EBC, both parties do not wish to treat it as a commercial scheme, hence EKL would not charge any fees/charges under this MOU.
- h. APAM is not liable to pay any charges to EKL unless agreed writing between the parties.
- i. EKL Dealers will provide a copy of the invoice to APAM beneficiaries along with the Tractor model and Business detail document's. Also EKL share monthly (APAM beneficiaries) data.
- j. EKL will provide APAM stickers/prints/designs/material as approved by APAM. Every EKL dealer agrees to display such material about APAM scheme without any cost so as to support the EBC Beneficiaries.

6.

- a. The MOU is entered into between the parties for the purpose of giving additional benefits to the beneficiaries in terms of special price of the product of EKL, specifically agriculture tractors to be purchased by beneficiaries for doing business as livelihood under the existing scheme of APAM. The special price list

for the products to be provided by the EKL to the beneficiaries is enclosed as **Annexure -1.**

- b. It is mutually agreed by both the parties that the beneficiary is free to choose any tractor/products available in the market from any company or from any dealer of any company for the business purpose under the existing scheme of APAM. And the MOU shall not make it mandatory or obligatory for the beneficiary to purchase the product of EKL. Both the parties understand and mutually agree that all the other companies/competitors who are original equipment manufacturers of tractors/products like tractors are free to come forward with similar offers to the beneficiaries of existing scheme of APAM and APAM is free to enter into any MOU or other form of MOU with each or any of such OEMs.
- c. For the purpose of awareness of existing and future beneficiaries of the existing schemes of APAM of this offer of discounted rates by the EKL, it is mutually agreed that the discount rates being part of the MOU will be put on the website of APAM. The list of authorized dealers and their showroom and location addresses is enclosed at **Annexure- 2.**

There shall not be any extra/additional charges levied or collected by the EKL or its authorized dealer from the beneficiaries for availing benefit of discounted rates under this MOU.

7. This MOU will be effective from the date of signing till 31st March'2024, This MOU may be further renewed, amended, modified by mutual written consent of both the Parties.
8. All necessary expenses for the performance of individual responsibilities of parties hereto shall be incurred by them on their own, unless specifically being agreed in writing.
9. Each Party owns, or is licensed to use, all trademarks, tradenames, copyrights, patents and other intellectual property material to its business, and the use thereof by the Party. No party shall make use of each other's Logo and/or Brand and/or intellectual property for any purpose without prior written permission of the individual Party.
10. Any provision under this MOU is found or proved to be illegal or invalid then only that provision or part of the provision shall be treated as null and void and remaining part shall be considered as enforceable and valid. MOU is applicable only for new products. (not for used product)
11. Any amendment to this MOU shall be carried out in writing duly authenticated and executed by all the parties.

12. This MOU may be terminated by any one of the parties giving a written notice of one months to other party. Any program or activity that has already commenced shall survive the termination of this MOU and be completed to the best of both Parties abilities pursuant and subject to the terms of this MOU.
13. EKL will regularly update its dealers list along with changes in the brochure and shall coordinate with APAM's DCO's (District Coordinator Officers) for the Scheme.
14. It is agreed, accepted and acknowledged by the Parties to this Agreement, that in case of any disputes, litigations, claims, losses to APAM, Bank or the Beneficiary, EKL shall not be responsible, liable in any manner whatsoever.
15. APAM and the Beneficiary confirms and undertake that EKL shall not be made party in any disputes/litigation/complaint/suits between themselves.
16. It is understood and agreed, and it is the intention of the Parties hereto, that APAM is an independent company, and not the employee, agent, joint venture partner of EKL for any purposes whatsoever. APAM hereby represents, warrants and covenants that APAM has the right, power and authority to enter into this MOU and that neither the execution nor delivery of this MOU, nor the performance of the Services by APAM will conflict with or result in a breach of the terms, conditions or provisions of, or constitute a default under, any contract, covenant or instrument under which APAM is now or hereinafter becomes obligated.
17. APAM hereby agrees, confirms and undertakes to indemnify EKL, its officials, directors, promoters etc. from and against any and all actions, suits, claims raised against EKL due to any breach of terms or condition of this MOU by APAM or its Personnel/Staff, and / or due to approved Bank.
18. Neither Party shall assign this MoU to any third party without the prior written consent of the other Party hereto.
19. All notices and other communications made or required to be given under this MOU shall be in writing and shall be effective upon receipt when sent by registered post, AD, courier service or hand delivery at the address as set out in the beginning of this MOU or to the address subsequently notified in writing by one Party to the other.

20. This MOU shall be governed, interpreted and construed in accordance with the Laws of India.

All matters, questions, disputes, difference or claims arising between the Parties in relation to or in connection with this MOU, its interpretation or application or as to the

21. Either party may terminate this MOU if any party is involved any corruption, illegal and unethical practices in any manner whatsoever.

22. Both Parties shall, at their own expense:

- a. strictly comply with all applicable laws, rules, regulations and governmental orders, now or hereafter in effect, relating to their performance under the MOU.
- b. pay all fees and other charges required by such laws, rules, regulations and orders; and
- c. maintain in full force and effect all licenses, permits, authorizations, registrations and qualifications from all applicable governmental departments and agencies to the extent necessary to perform their obligations hereunder survive the expiry or termination of the MOU.
- d. The relationship of the Parties under this MOU shall be non-exclusive and both parties are free to pursue other agreements of collaborations of any kind.

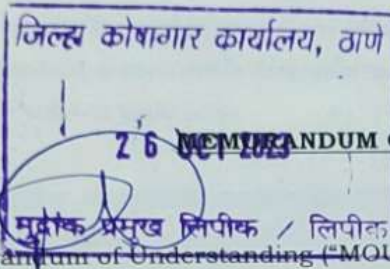
